

2018-19 Annual report on water compliance activities for the Murray-Darling Basin Authority

The Murray-Darling Basin Authority (MDBA) as an independent regulator, has responsibility for enforcing the *Water Act 2007* (Cth) (Water Act), the *Basin Plan 2012* (Cth) (Basin Plan) and ensuring compliance with water resource plans once they have been accredited. Basin state water agencies have day to day responsibility for water planning, water licensing, rule setting and state level compliance on issues relating to illegal water and metering.

Compliance and enforcement activities should be initiated at the appropriate jurisdictional level for the issue concerned. Where the MDBA receives allegations of non-compliance on issues where the Basin state has regulatory responsibility, these are referred on to the appropriate water agency for consideration. In these cases the MDBA follows up with state agencies on a regular basis to ensure the MDBA is satisfied with action taken by the relevant state.
